They were examined by us under consideration of the

DIN EN 71, part 11 "Safety of Toys, Organic chemical compounds – Methods of analysis", state of January 2006.

The paper grades are in compliance with the rules of the

concerning primary aromatic amines and not approved colorants.

Thus the paper grades **Klaflute Especial** and **Klaflute Premium** according to the sample material submitted may be used safely for food packaging. They may stand in direct contact with dry, moist and fatty foodstuffs.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
